Introduction:

This report considers the current polling district, polling place and polling station arrangements for residents within Blaby District. Specifically, it considers whether current arrangements provide reasonable facilities for voting.

The ARO has taken into account any known issues when conducting this review and where appropriate, council officers have visited polling stations to consider and make comment on their suitability for voters.

Background:

In accordance with the Representation of the People Act 1983, The Electoral Administration Act 2006 and the Electoral Registration and Administration Act 2013, Blaby District Council is required to conduct a review of its polling places and polling districts every five years. The current compulsory review begins on 1 October 2023 and must conclude by 31 January 2025.

This review is also necessary as a result of recommended changes to Parliamentary constituency boundaries. The Boundary Commission for England (BCE) published their final recommendations in June 2023. These recommendations set out a new scheme of Parliamentary Constituencies for England. Whilst the recommendations for constituencies contained within Blaby District do not necessitate changes to the existing schedule of polling districts, it is appropriate to still conduct a review at the earliest opportunity during the compulsory review period to ensure that all polling places remain fit for purpose in preparation for the next general election.

These recommendations refer to the new parliamentary constituency boundaries.

Once the review concludes, the Electoral Registration Officer (ERO) must make the necessary amendments to the Register of Electors. These will be published as part of the Annual Publication of the register on 1 December 2023.

Definitions

A polling district is a sub-division of a parliamentary constituency contained within a district. It is a purely administrative area which has no material impact on the voting experience of residents.

A polling place refers to the area in which the (Acting) Returning Officer will locate a polling station.

A polling station is the room in which voting takes place.

Guidelines:

Factors which much be considered by the (Acting) Returning Officer when reviewing polling places:

- The authority must seek to ensure that all electors have such reasonable facilities for voting as are practicable in the circumstances
- The authority must seek to ensure that so far as is reasonable and practicable every polling place is accessible to electors who are disabled
- The polling place for a polling district must be an area in the district, unless special circumstances do not allow this
- Each parish must be a separate polling district
- The Electoral Commission guidance states that there should be no more than 2,250 electors voting in a polling station. This is lower than previous guidance which recommended a maximum of 2500 electors.

The (Acting) Returning Officer should consider the following features of a polling station when reviewing its suitability:

- Location- Is it reasonably accessible within the polling district and are there any barriers for voters e.g steep hills and major roads?
- Size- Can it accommodate the required number of electors?
- Availability- Is the building readily available in the event of any unscheduled elections?
- Accessibility- Is the building accessible to those entitled to attend the polling place?
- Due regard should also be given to existing electoral boundaries for County divisions, Parishes and District wards

Returning Officer's Recommendations:

Polling District A2: Concerns regarding the accessibility of the polling station at Blaby Parish Centre were raised at the recent District & Parish Elections, specifically in relation to the entrance of the Centre. Officers conducted a visit to the venue and determined that whilst there is a small lip at the door, the facilities for voting provided are reasonable, and disabled access is still possible. The building keyholder confirmed that electronic scooters are able to pass through the entrance with no issues. The ARO proposes to retain Blaby Parish Centre as a polling place and polling station for electors in Polling District A2 as feedback and investigation indicates that this polling place provides reasonable facilities for voting. Polling districts A1 and A2 will form one polling station, which will comply with EC requirements.

Polling District B: No amendments to the current polling arrangements are proposed. The ARO proposes to retain the existing polling place and polling station for electors in Polling District B as review and feedback indicates that this polling place provides reasonable facilities for voting. Polling districts B and C will remain combined as one polling station.

Polling District C: No amendments to the current polling arrangements are proposed. The ARO proposes to retain the existing polling place and polling station for electors in Polling District C as review and feedback indicates that this polling place provides reasonable facilities for voting. Polling districts B and C will remain combined as one polling station.

Polling District D: No amendments to the current polling arrangements are proposed. The ARO proposes to retain the existing polling place and polling station for electors in Polling District D as review and feedback indicates that this polling place provides reasonable facilities for voting. The ARO recognises that the number of voters at this polling station slightly exceeds the Electoral Commission's recommended level. The ARO proposes to alleviate any additional pressures caused by the number of voters at this station through the provisional of additional staff and equipment.

Feedback from polling station staff has indicated that the mobile unit it not large enough to adequately accommodate the volume of voters in this polling district. Officers have met with the Head Teacher of Pastures who raised concerns regarding the use of the school buildings. With this in mind, alternative options have been explored in detail, including a visit to Red Hill Fields Primary School. However, no suitable alternative building has been identified as appropriate for use as a polling station. Red Hill school would need to shut in order to accommodate a polling station. It is therefore proposed that a flexible approach to use of the venue is applied. At larger turnout elections, use of the school hall is required. At lower turnout elections, a mobile unit will be appropriate.

Officers conducted a visit to the venue and determined that whilst there is a small lip at the door, the facilities for voting provided are reasonable, and disabled access is still possible. The building keyholder confirmed that electronic scooters are able to pass through the entrance with no issues. The ARO proposes to retain Blaby Parish Centre as a polling place and polling station for electors in Polling District A2 as feedback and investigation indicates that this polling place provides reasonable facilities for voting.

Returning Officer's Recommendations:

Polling District DJ1 & DL2: The ARO proposes to combine Polling District DJ1 with Polling District DL2, with the new Polling District designation DL. Park House will remain the designated polling station to provide reasonable facilities for voting in this polling district. Polling District DJ1 and Polling District DL2 share the same local boundaries, county divisions, district ward and parliamentary constituency meaning that combining the polling districts is a common sense and practical approach.

These two polling districts were created as a result of the LGBCE electoral review, which necessitated the creation of a scheme of polling districts which could reflect both the old ward boundaries, and the new ones. The ordinary election of District Councillors took place on 4th May 2023. There is now therefore no requirement for the old boundaries to be reflected in the scheme of polling districts and therefore the two can now be combined.

DJ1 contains 1121 electors (excluding postal voters). DL2 contains 739 electors (excluding postal voters), The combination of the two polling districts would result in a total electorate of 1860, which is below the Electoral Commission's suggested maximum level of 2250.

Polling District DK: The ARO proposes to retain the existing polling place for electors in Polling District DK as review and feedback indicates that this polling place provides reasonable facilities for voting. Polling district DK will be combined with polling district DO to form one polling station at parliamentary elections. The ARO recognises that the number of voters at this polling station will exceed the Electoral Commission's recommended level with 2736 voters. However this arrangement will result in a significantly smaller electorate than has historically voted at this polling station (4143 electors). The ARO proposes to alleviate additional pressures caused by the number of voters at this station through the provisional of additional staff and equipment.

Returning Officer's Recommendations:

Polling District DJ2 & DM: The ARO proposes to combine Polling District DJ2 with Polling District DM, retaining the Polling District designation DM. Voters from DJ2 will now vote at The Hall School. Polling District DJ2 and Polling District DM share the same local boundaries, county divisions and parliamentary constituencies meaning that combining the polling districts is a common sense and practical approach.

Polling district DJ2 was created as a result of the LGBCE electoral review, which necessitated the creation of a scheme of polling districts which could reflect both the old ward boundaries, and the new ones. The ordinary election of District Councillors took place on 4th May 2023. There is now therefore no requirement for the old boundaries to be reflected in the scheme of polling districts. It is not practical to retain a polling district with only 116 voters.

DJ2 contains 116 electors (excluding postal voters). DM contains 872 electors (excluding postal voters), The combination of the two polling districts would result in total electorate of 988, which is below the Electoral Commission's suggested maximum level of 2250.

Polling District DL1 & DN:

The ARO proposes to combine Polling District DL1 with Polling District DN, retaining the Polling District designation DN. The Hall School will remain the designated polling station to provide reasonable facilities for voting in this polling district. Polling District DL1 and Polling District DN share the same local boundaries, county divisions and parliamentary constituencies meaning that combining the polling districts is a common sense and practical approach.

These two polling districts were created as a result of the LGBCE electoral review, which necessitated the creation of a scheme of polling districts which could reflect both the old ward boundaries, and the new ones. The ordinary election of District Councillors took place on 4th May 2023. There is now therefore no requirement for the old boundaries to be reflected in the scheme of polling districts.

DL1 contains 167 electors (excluding postal voters). DN contains 1174 electors (excluding postal voters), The combination of the two polling districts would result in a total electorate of 1341, which is below the Electoral Commission's suggested maximum level of 2250.

Polling District DO: The ARO proposes to retain the existing polling place and polling station for electors in Polling District DO as review and feedback indicates that this polling place provides reasonable facilities for voting. Polling district DK will be combined with polling district DO to form one polling station at parliamentary elections. The ARO recognises that the number of voters at this polling station will exceed the Electoral Commission's recommended level with 2736 voters. However this arrangement will result in a significantly smaller electorate than has historically voted at this polling station (4143 electors). The ARO proposes to alleviate additional pressures caused by the number of voters at this station through the provisional of additional staff and equipment.

The ARO recognises that the number of voters at this polling station exceeds the Electoral Commission's recommended level. The ARO proposes to alleviate any additional pressures caused by the number of voters at this station through the provisional of additional staff and equipment.

Polling District DQ: No amendments to the current polling arrangements are proposed. The ARO proposes to retain the existing polling place and polling station for electors in Polling District DQ as review and feedback indicates that this polling place provides reasonable facilities for voting.

Returning Officer's Recommendations:

Polling District DR1 & DS2: The ARO proposes to combine Polling District DR1 with Polling District DS2, with the Polling District designation DR. Stafford Leys Community Centre will remain the designated polling station to provide reasonable facilities for voting in this polling district. Polling District DR1 and Polling District DS2 share the same local boundaries, county divisions and parliamentary constituencies meaning that combining the polling districts is a common sense and practical approach.

These two polling districts were created as a result of the LGBCE electoral review, which necessitated the creation of a scheme of polling districts which could reflect both the old ward boundaries, and the new ones. The ordinary election of District Councillors took place on 4th May 2023. There is now therefore no requirement for the old boundaries to be reflected in the scheme of polling districts. DR1 contains 63 electors (excluding postal voters). DS2 contains 558 electors (excluding postal voters), The combination of the two polling districts would result in a total electorate of 621, which is below the Electoral Commission's suggested maximum level of 2250.

Polling District DS1: No amendments to the current polling arrangements are proposed. The ARO proposes to retain the existing polling place and polling station for electors in Polling District DS1 as review and feedback indicates that this polling place provides reasonable facilities for voting.

Polling District DT: No amendments to the current polling arrangements are proposed. The ARO proposes to retain the existing polling place and polling station for electors in Polling District DT as review and feedback indicates that this polling place provides reasonable facilities for voting. The ARO recognises that the number of voters at this polling station exceeds the Electoral Commission's recommended level. The ARO proposes to alleviate any additional pressures caused by the number of voters at this station through the provisional of additional staff and equipment.

Polling District E2, F2 & H2:

Following responses received as part of the public consultation on the ARO's proposals, the boundary between existing polling districts G and H2 will be amended to create a more logical geographical split. All of Chislehurst Avenue and Ashurst Road will be moved from G to H2. Voters living on these roads will now vote at St Crispin's Church, which provides good facilities for voting. All of Brokenhurst Road, Fieldhurst Avenue and The Kingsway properties up to number 126 will now be moved from H2 to G. Voters from these roads will now vote at Millfield Community Nursery which provides good facilities for voting.

The ARO also proposes to combine Polling District E2, Polling District F2 and Polling District H2, retaining the Polling District designation H2. St Crispin's Church will remain the designated polling station to provide reasonable facilities for voting in this polling district. Polling Districts E2, F2 and H2 share the same local boundaries, county divisions and parliamentary constituency meaning that combining the polling districts is a common sense and practical approach.

These polling districts were created as a result of the LGBCE electoral review, which necessitated the creation of a scheme of polling districts which could reflect both the old ward boundaries, and the new ones. The ordinary election of District Councillors took place on 4th May 2023. There is now therefore no requirement for the old boundaries to be reflected in the scheme of polling districts.

E2 contains 287 electors (excluding postal voters). F2 contains 62 electors (excluding postal voters), H2 contains 1398 electors. The combination of the three polling districts would result in a total electorate of 1747, which is below the Electoral Commission's suggested maximum level of 2250.

Polling District G: Following responses received as part of the public consultation on the ARO's proposals, the boundary between polling districts G and H2 will be amended to create a more logical geographical split. All of Brokenhurst Road, Fieldhurst Avenue and The Kingsway properties up to number 126 will now be moved

from H2 to G. Voters from these roads will now vote at Millfield Community Nursery. All of Chislehurst Avenue and Ashurst Road will be moved from G to H2. Voters living on these road will now vote at St Crispin's Church, which provides good facilities for voting.

Returning Officer's Recommendations:

Polling Districts E1, F1: The ARO proposes to combine Polling District E1, Polling District F1, with the Polling District designation I. Polling Districts E1 and F1 share the same local boundaries, county divisions and parliamentary constituency meaning that combining the polling districts is a common sense and practical approach.

These two polling districts were created as a result of the LGBCE electoral review, which necessitated the creation of a scheme of polling districts which could reflect both the old ward boundaries, and the new ones. The ordinary election of District Councillors took place on 4th May 2023. There is now therefore no requirement for the old boundaries to be reflected in the scheme of polling districts.

E1 contains 491 electors (excluding postal voters). F1 contains 428 electors (excluding postal voters). The combination of the polling districts would result in a total electorate of 919, which is below the Electoral Commission's suggested maximum level of 2250.

Historically, voters in E1 and F1 have voted at Braunstone Working Men's Club. The site has now been sold and demolition work has begun. It is therefore necessary to move voters to a new polling place. The ARO proposes that Riverside Football Pavilion, located on the grounds of Ellesmere College becomes the designated polling station to provide reasonable facilities for voting in this polling district. Whilst this venue sits just outside the border of Blaby district, it is still within reasonable distance for voters. The venue has good disabled access, good transport links, is a clearly identifiable building for voters and is of a sufficient size for the number of electors.

Polling District I: Following responses received as part of the public consultation on the ARO's proposals, it was felt that Riverside Football Pavilion was not convenient for voters in polling district I. It is therefore recommended that voters in I vote at Braunstone Civic Centre. Feedback from the consultation indicated that voters in this area historically voted at the Civic Centre, and that it has convenient access through Franklin Park. The ARO is satisfied with this proposal.

The ARO proposes to combine Polling District I and Polling District H1, with the Polling District designation H1. Polling Districts I and H1 share the same local boundaries, county divisions and parliamentary constituency meaning that combining the polling districts is a common sense and practical approach.

Polling district I contains 516 electors. Polling district H1 contains 1394 electors. The combination of the polling districts would result in a total electorate of 1910, which is below the Electoral Commission's suggested maximum level of 2250.

Polling District H1: The ARO proposes to combine Polling District I and Polling District H1, with the Polling District designation H1. Polling Districts I and H1 share the same local boundaries, county divisions and parliamentary constituency meaning that combining the polling districts is a common sense and practical approach.

Polling district I contains 516 electors. Polling district H1 contains 1394 electors. The combination of the polling districts would result in a total electorate of 1910, which is below the Electoral Commission's suggested maximum level of 2250.

The ARO proposes to retain the existing polling place and polling station for electors in Polling District H1 as review and feedback indicates that this polling place provides reasonable facilities for voting.

Polling District L: No amendments to the current polling arrangements are proposed. The ARO proposes to retain the existing polling place and polling station for electors in Polling District L as review and feedback indicates that this polling place provides reasonable facilities for voting.

Returning Officer's Recommendations:

Polling District DR2: No amendments to the current polling arrangements are proposed. The ARO proposes to retain the existing polling place and polling station for electors in Polling District DR2 as review and feedback indicates that this polling place provides reasonable facilities for voting.

Polling District J: No amendments to the current polling arrangements are proposed. The ARO proposes to retain the existing polling place and polling station for electors in Polling District J as review and feedback indicates that this polling place provides reasonable facilities for voting.

Polling District K1 and K2: K1 and K2 were historically split into two polling districts to reflect that a very small section of Braunstone (K2) was within the old Charnwood constituency, whilst the larger K1 was in the South Leicestershire constituency. Both polling districts share the Thorpe Astley Community Centre polling station. Following the recent BCE review of parliamentary boundaries, both K1 and K2 in their entirety have been moved to the Mid Leicestershire constituency.

To ensure that there is no duplication of polling district codes between Blaby District Council and Charnwood Borough Council, it is proposed that K2 is re-designated as polling district K.

It is necessary to create a schedule of polling districts which is able to reflect both the old constituency boundaries, and the new ones, until the next general election has been held. This is to enable the provision of copies of the electoral register using the old boundaries to the incumbent Members of Parliament, and to allow the administration of a by-election on old boundaries should one be held before the next General Election. As such, K1 and K2 must remain as separate polling districts for the time being.

Once the next general election has been held, there will be no requirement to reflect both the new and old boundaries in the schedule of polling districts. K1 contains 2291 electors (excluding postal votes). K2 comprises of only 152 electors (excluding postal votes). It is therefore proposed that it would therefore be practical to combine K1 and K2 to form polling district K following the next general election.
