The Council's political management arrangements are based on a single-party, 6 member Cabinet Executive with delegated powers. This is counter-balanced by an 11 member Scrutiny Commission with

Executive with delegated powers. This is counter balanced by an 11 member Scrutiny Commission with two Scrutiny Commissioners. The Council also appoints a number of other Committees and Panels through which it conducts its business.

The Council operates a Members' Allowances Scheme which includes payment of a Basic Allowance to all Members, together with Special Responsibility Allowances payable to the holders of designated posts, such as the Leader of the Council, Cabinet Members, Scrutiny Commissioners, Committee Chairmen, Political Group Leaders and Cabinet Lead/Support Appointments. Members may also make claims for travel and subsistence allowances for carrying out duties as specified under the Scheme.
